

## MANAGED SOLUTIONS PACKAGE:

1. User access: The number of users included in the price of your service plan. Need more user profiles, no worries just let us know!
2. Offline Capability: Have the ability to work the app offline. Important safety info can be accessed via the app at any time, while new information can be saved and synced to the cloud when your app reconnects to a network.
3. Written risk assessments: One of our team will carry out a full risk assessment (RA) on 5 areas which pose the highest risk. More RA's can be completed at an additional cost.
4. Safety Rating: The app will provide an overview of your actions and will help to guide you by highlighting areas that require improvements using a traffic light system.
5. Hazard Maps: Plot hazards on an interactive map. Add detailed info and images to provide context.
6. Assign farm specific inductions: Select, edit and send inductions to staff inductions to staff for sign off.
7. Emergency response and health action plans: In case of an emergency, allow workers to quickly access vital emergency details e.g response plans, key contacts and directions for the emergency services.
8. Access to a range of farm specific policies and procedures: Create, edit and sign off company policies and industry specific safe working procedures written by Qualified Safety Professionals following HSE's requirements.
9. Chemical Register: Input chemicals found around the farm and communicate hazards associated with them. There is also the option to link the safety data sheet to the chemical in case of an emergency.
10. Machinery and equipment management: Stay on top of maintenance, procedures, license requirements and expiry dates with detailed records.
11. Structure and Tool Management: Log evidence of maintenance and schedule reminders to ensure compliance is retained.
12. Near Miss, Incident and RIDDOR Reporting: Capture the right information in an investigation with intuitive near miss and incident reporting. Quickly identify improvements and initiate call to actions when reoccurring incidents happen.
13. Task Manager: Create new tasks to one or multiple employees to increase efficiency of daily operations. This feature also gives employees the opportunity to report risks as they happen on farm.
14. Reporting: Data can be extracted by your Consultant to demonstrate a proactive health and safety sculture on your farm.
15. Scheduled Training Register: Maintain your workers tickets, certificates and licences by setting expiry dates to receives reminders for when they need renewing.

2. On farm visit to implement Safe Ag Systems, complete a staff induction session and carry out a paper-based risk assessment tour. ON larger units with more staff this may be done on multiple days or virtually.
3. You will receive a 6 monthly Audit either virtually or in person depending on how you have progressed using the app.
4. Phone call check-ups: We are able to view your progress, so if you're getting on well you don't need to hear from us; on the other hand if there isn't much activity we will give you a call to see if you need a little assistance.
